

**ASSUMPTION OF RISK, RELEASE, AND INDEMNIFICATION AGREEMENT FOR
USE OF DOG PARK**

The undersigned and his or her parent or legal guardian, if the undersigned is under 18 years of age, in consideration of membership in the Dog Park Association of Greater Lafayette, Indiana, Inc. ("Dog Park Association") and permission to use the dog park operated by the Lafayette Parks Department and the Dog Park Association hereby expressly agree to the following:

- 1) I/we am/are fully aware of the risks and hazards in or arising from using the dog park. I/we hereby assume any and all risks, whether foreseen or unforeseen, and responsibility for any harm, injury, or damage which may arise from my/our use of or presence at the dog park and surrounding property, including, without limitation, the risk of bodily injury to me/us resulting from dog bites, viruses, or parasites, the risk of bodily injury, illness, or disease to my/our dog, the condition of the property, or the negligent or deliberate act of another person. The undersigned hereby accept(s) any and all responsibility for his/her/their own safety and welfare and the safety and welfare of my/our dog while at the dog park and surrounding property;
- 2) I/we agree to forever release, discharge, waive, and relinquish any and all actions or causes of action of liability against the Dog Park Association, the City of Lafayette, the Lafayette Parks Department, and the members, employees, directors, officers, and agents of the Dog Park Association, the City of Lafayette, and the Lafayette Parks Department (collectively the "Released Parties"), for any injuries, damages, losses or claims, whether known or unknown, including but not limited to, claims related to personal injury, property damage, wrongful death, and injuries, and illness, disease, or injury to my/our dog, which arise during or as a result of my/our use of or presence at the dog park and surrounding property or my/our dog's use of or presence at the dog park and surrounding property, whether or not caused in whole or in part by the negligence or other fault of any of the Released Parties. I/we release and forever discharge the Released Parties from all such claims;
- 3) I/we agree to indemnify and hold the Released Parties harmless from all losses, liabilities, damages, costs, or expenses (including but not limited to reasonable attorneys' fees and other costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I/we (or anyone claiming by, under or through me/us) or any third party may bring against any of the Released Parties to recover any losses, liabilities, costs, damages, or expenses which arise during or as a result from my/our use of or presence at the dog park and surrounding property, or my/our dog's use of or presence at the dog park and surrounding property, regardless of whether or not caused in whole or part by the negligence or other fault of any of the Released Parties.

4) I/WE HAVE READ AND UNDERSTOOD THIS AGREEMENT. I/WE UNDERSTAND THAT BY MAKING AND SIGNING THIS AGREEMENT, I/WE SURRENDER VALUABLE RIGHTS, INCLUDING, BUT NOT LIMITED TO THE RIGHT TO SUE. I/WE DO SO FREELY AND VOLUNTARILY.
